

Privacy Policy

This privacy policy applies between you, the User of this Website and any Rimo3 software applications, and Rimo3 Ltd, the owner and provider of this website. Definitions and interpretation

Data	Collectively all information that you submit to Rimo3 Ltd via the Website. This definition incorporates, where applicable, the definitions provided in the REGULATION (EU) 2016/679 OF THE EUROPEAN PARLIAMENT AND OF THE COUNCIL of 27 April 2016 (“GDPR”) and in the Data Protection act 1998;
Cookies	A small text file placed on your computer by this Website when you visit certain parts of the website and/or when you use certain features of the website. Details of the cookies used by this website are set out in the clause below (Cookies);

UK and EU Cookie Law	The privacy and electronic communications (EC Directive) Regulations 2003 as amended by the privacy and electronic communications (EC Directive) (Amendment) Regulations 2011;
User or you	Any third party that accesses the Website and is not either (i) employed by Rimo3 Ltd and acting in the course of their employment or (ii) engaged as a consultant or otherwise providing services to Rimo3 Ltd and accessing the Website in connection with the provision of such services; and
Website	The website that you are currently using, www.Rimo3.com and any sub-domains of this site unless expressly excluded by their own terms and conditions

2. In this privacy policy unless the context requires a different interpretation
 - a. The singular includes the plural and vice versa;
 - b. The references to sub-clauses, clauses, schedules or appendices are to sub-clauses, clauses, schedules or appendices of this privacy policy;
 - c. A reference to a person includes firms, companies, government entities trusts and partnerships;
 - d. “including” is understood to mean “including without limitation”;
 - e. Reference to any statutory provision includes any modification or amendment of it;
 - f. The headings and sub-headings do not form part of this privacy policy.

Scope of this privacy policy

3. This privacy policy applies only to the actions of Rimo3 Ltd and Users with respect to this Website. It does not extend to any websites that can be accessed from this Website including, but not limited to, any links we may provide to social media websites.

Data collected

4. We may collect the following data, which includes personal Data, from you:
 - a. Name
 - b. Job Title;

 - d. Contact Information such as email addresses and telephone numbers; in each case, in accordance with this privacy policy

Our use of data

5. For purposes of the data protection act 1998, Rimo3 Ltd is the “data controller”.

6. We will retain any data you submit for 3 years
7. Unless we are obliged or permitted by law to do so, and subject to any third party disclosures specifically set out in this policy, your Data will not be disclosed to third parties. This includes our affiliates and/or other companies within our group.
8. All personal data is stored securely in accordance with the principles of the data protection act 1998. For more details on security see the clause below (**Security**)
9. Any or all of the above data may be required by us from time to time in order to provide you with the best possible service and experience when using our website. Specifically data may be used by us for the following reasons:
 - a. Improvement of our products/services;
 - b. Transmission by email of promotional materials that may be of interest to you;

14. In the above instances, we will take steps with the aim of ensuring your privacy is protected.

34. This agreement will be governed by and interpreted according to the law of England and Wales. All disputes arising under the agreement will be subject to the exclusive jurisdiction of the English and Welsh courts.
